Schwarz and Carey Present at PA Land Conservation Conference

The 2012 Pennsylvania Land Conservation Conference was held at Pocono Manor in May. Charlie Schwarz was a panelist on "Home on the Shale" which Reneé Carey moderated. The day-long session also included land trust staff from the North Branch Land Trust, The Nature Conservancy, Delaware Highlands Conservancy, and Western Pennsylvania Conservancy.

The Pennsylvanians were joined by two Coloradians - Melinda Beck and Kathleen Staks. Melinda is an attorney who has worked on a variety of projects involving gas development. Kathleen is with the Colorado Coalition of Land Trusts and was instrumental in creation of "Mineral Development and Land Conservation: A Handbook for Conservation Professionals".

The panelists presented their experience in stewarding and conserving properties with the recent increase in gas development activities. There was also some discussion on recent and pending court cases in Pennsylvania addressing mineral ownership.
